It is the entrant's responsibility to ensure they have current car club membership and a current CAMS license (as per supplementary regulations) **prior** to scrutineering. **Purchasing/joining/renewing car club membership and CAMS licenses will not be offered at scrutineering or on the morning of the event.**

Existing members of a CAMS affiliated car club **must ensure they have a current membership card** ready for presentation. Expired cards cannot be accepted.

If you are not a member of CAMS affiliated car club you may choose to join Club Motori Italia (www.cmitas.org) or another CAMS affiliated car club of your choice. If you do not have a CAMS license you will need to organise it via CAMS, see www.cams.com.au.

Scrutineering Checklist
